**Features:** The chequing account is a non-interest bearing account that provides for an attractive and effective means of maintaining a record of spending. These accounts are available for members age 60 and up.

### **Heritage Chequing** **\$2.00 per month**

Includes unlimited transactions and monthly statement.

Includes Utility Bill payments, free deposits, free online and mobile banking, first debit card free. (Replacement/Additional Card \$10 Fee)

### **US Dollar Account**

Must operate a Heritage Chequing account.

\$0.75 per transaction

### **Plan 24** **\$2.00 Semi-Annual Statement Fee**

The Plan 24 savings account provides interest and account access at the depositors convenience. Interest is calculated on the daily closing balance and credited to the account at the end of the month.

### **Investment Account**

**Features:** A high interest savings account with a “cumulative” rate index. A cumulative tiered index is one where there are multiple tiers and whatever tier corresponds with the account’s balance will apply to ALL funds in the account based on the closing balance.

Premium rate on balances over \$20,000. Interest is calculated daily closing balance and paid monthly. Interest rate is daily and could change daily. Transactions may be made in branch or through MemberDirect.

One free debit per month. Additional debits are \$5 per transaction.

No chequing privileges or access through POS or ATM.

Paper statements are provided on all plans. The monthly statement is produced as of the 26<sup>th</sup> of each month. Semi Annual Statement option is produced end of June and December. Imaged cheques are provided with each chequing statement. Options for electronic statements are available.
